In consideration of my participation in any one of Making Faces Productions, Inc.'s activities, I acknowledge that I understand the nature of the activity and that I, and /or my minor child, am qualified, in good health, and in proper physical condition to participate in such activity. I acknowledge that if conditions are unsafe, I, and/or my minor child, will immediately discontinue participation in any activity.

I fully understand that dance and other movement activities related to Intention Dance Theater and Making Faces Productions' Los Angeles Improv Dance Festival may involve risks of serious bodily injury, including permanent disability, paralysis, and death, and that these and other risks may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the Releasees named below; and that there may be other risks either not known to me or not foreseen at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the activity. In the case of serious injury to myself, and /or my minor child, in which a parent or guardian cannot be contacted immediately, I hereby authorize Making Faces Productions, Inc. staff, volunteers, and other participants to apply any necessary medical care and to contact emergency medical support as soon as possible.

I hereby release, discharge, and covenant to not bring legal action against Electric Lodge, Intention Dance Theater, or Making Faces Productions, Inc. it's patrons, Board of Directors, their respective administrators, directors, agents, officers, volunteers, and employees, (each considered one of the Releasees herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees.
